# HOW TO: Complete a Transfer Application

1. Ensure that horse changing hands is a Registered Australian Stock Horse. Send the Transfer Application to Head Office regardless of whether the new owner is a Member of the Society or not

2. Transfer costs and conditions may vary - consider this section carefully as you may be eligible for bulk rates or family discounts.

3. Complete the Name of Horse, Reg No (Full Australian Stock Horse Registration Number), Sex, Colour

4. Complete the Change of Ownership Details  
\* Previous Owner - is the the last Registered owner. The person who is selling/giving away the horse

\* New Owner - be sure to include as much detail as possible in the New Owner's details so the Society is able to contact them

5. Complete the Date Horse Changed Ownership - this is the date that the horse actually changed hands

6. Signature of Vendor - this is Last Registered Owner's signature - the person who is selling/giving away the horse

7. Date - is the date that the Vendor has signed the form

8. Attach payment - Cheque, Money order or complete the Credit Card details

9. Attach ORIGINAL Certificate of Registration

10. Send to Head Office via post as the Original Certificate is required for the transfer to be processed

Note: If you are a non-Member you may include your Membership application with the Transfer Application

**Transfer Application**  
Transfer Fee \$45.00. Unless the Transfer Fee is attached, it will be assumed that the purchaser will pay the fee.

The Vendor must submit the signed Transfer Application and the Certificate of Registration directly to the Society immediately a change of ownership takes place. The Transfer Application must be signed by the Nominee or Authorised Agent of the Membership of the last registered owner. **Please note:** When a Transfer has been recorded by the Society, the Certificate of Registration will be forwarded to the new owner provided he/she is a Financial Member of the Society and the prescribed Transfer fee has been paid.

**TRANSFER: \$45 per transfer, or \$170 for unlimited transfers from one Membership directly to one other Membership.**  
**FAMILY TRANSFER REDUCTION: \$25 per transfer or \$85 for unlimited transfers.** Eligibility to claim reduction as below:  
The nominee of the new owner's membership and the nominee of the previous owner's membership must not exceed two generations and be either the son/stepson/grandson or daughter/stepdaughter/granddaughter of the current owner of the horse and includes legally adopted or fostered children. The nominee of the new owner's membership must be under 25 years of age. To claim the reduction please complete:

 Attach foal's Certificate of Registration or the ASH Breeding Certificate with the service details completed and signed by the Stallion Owner, plus the Application for Registration with the foal's details duly completed. Attach ASH Breeding Certificate, with service details duly completed and signed by the stallion owner.

Stallions - If Semen has been collected, it must be disclosed prior to sale. Mares - If Embryos have been collected, it must be disclosed prior to sale.
