REGULATIONS - Export Approval will be granted in respect of a Registered Australian Stock Horse if:

- The prescribed Export Application Fee is paid;
- The owner of the horse is a financial member of the Society at the time of application;
- The horse is DNA Recorded; and
- A Society Inspector certifies in writing that the brand and other identifying marks on the horse (as outlined in Rules and Regulations) are accurately recorded and consistent with those shown on the horse's Certificate of Registration.
