A Member may nominate a horse owned by themselves or a horse belonging to another Member.

On a separate sheet attached to the Nomination Form, submit a profile for the horse with details of its achievements in three event categories in the calendar year of 2018. The emphasis is on the prestige of the awards achieved, and not the number of places won in events over the 12 month period. The nomination should include the reasons why the horse should be selected for the Trophy. Please include at least 5 photos suitable for publication.
