# The Australian Stock Horse Society Limited HOW TO: Complete a Transfer Application

1. Ensure that horse changing hands is a Registered Australian Stock Horse. Send the Transfer Application to Head Office regardless of whether the New Owner is a Member of the Society or not.

Note: If you are a non-Member you may include your Membership application with the Transfer Application

2. Transfer costs and conditions may vary - consider this section carefully as you may be eligible for bulk rates or Youth discounts.

3. Complete the Name of Horse, Reg No (Full Australian Stock Horse Registration Number), Sex and Colour.

4. Complete the Change of Ownership Details

- Previous Owner - the last Registered owner. The person who is selling/giving away the horse.
- New Owner - include as much detail as possible so the Society is able to contact them.

5. Complete the Date Horse Changed Ownership - date that the horse actually changed hands.

6. Signature of Previous Owner

7. Date - date that the Vendor signed the form.

8. Attach ORIGINAL Certificate of Registration.

9. Attach payment - Cheque, Money order or complete the Credit Card details.

10. Send to Head Office via post as the Original Certificate is required for the transfer to be processed.

## Transfer Application

Unless the Transfer Fee is attached, it will be assumed that the purchaser will pay the fee.

For continuity of registration, the change of Registered Owner must be completed on Society records. To ensure the transfer is finalised, we provide the following important points:

- The nominee for the Last Registered Owner of the horse must sign the Transfer Application and return it to the Society with the horse's Certificate of Registration. Signature on the application must coincide with Society records.
- The New Owner must be a Financial Member of the Society. Transfers will not be effected to unfinancial or non-members of the Society.
- Payment of the transfer fee is an agreement between the vendor and purchaser. If payment is not received from the Vendor, it will be assumed that the purchaser will pay the fee.
- If the horse is purchased by multiple new owners, a Syndicate Transfer Application must be completed.
- The horse's registration will be suspended until such times as the transfer is finalised and the Certificate of Registration forwarded to the New Owner.
