ELIGIBILITY

Eligible horses must have **ONE** grandparent or **TWO** great-grandparents registered as **Australian Stock Horses** with **HERITAGE STOCK HORSE** status.

Mares, fillies, stallions, colts and geldings are eligible.

Horses with one unknown or unidentified parent may be registered.

REQUIREMENTS

- ✓ Horses must pass inspection by a Society Inspector.
- ✓ Horses must be DNA Parentage Tested (if available).
- ✓ Mares and fillies must be Genetic Disorder Tested for Herda.
- ✓ Stallions and Colts must be 6 panel Genetic Disorder Tested for OLWS, HERDA, GBED, PSSM1, HYPP and MH.
- ✓ Horses must be branded - owner, identification and year.

FORMS, PROCEDURES AND FEES

Horses must be branded and inspected by Society Inspector, or video footage provided.

Application for Registration with ASH Breeding Certificate submitted with payment of fees.

DNA kit will be issued when completed application for eligible horse is received by the Society.

MARES & FILLIES - Includes DNA parentage & HERDA

- Under 4yrs \$300.00
- 4yrs & over \$360.00

GELDINGS - Includes DNA parentage only

- Any Age \$220.00

STALLIONS & COLTS - Includes DNA parentage & 6 panel GDT

- Under 4yrs \$530.00
- 4yrs & over \$710.00

SIRE REGISTRATION in addition to the above fee - \$280.00

Genetic Disorder Results will be noted on Registration.
