PREFIX APPLICATION

The initial part of a horse's name is the Prefix.

- Australian Stock Horse Breeders may use a standard Prefix when naming horses, if registered.
- Members may register a Prefix for standard naming of horses, or use a different name (including Prefix) for each horse registered.
- A member is unable to use a standard word when naming horses unless registered as a prefix.

To register a Prefix, you must seek registration from the Society.

- It is a perfect way of recognising the Stud and horses bred for years to come.
- It provides a convenient and simple way to name horses.
- The performance of horses bred by the Stud and overall success of the Stud are easily recognised.
- At sales, horses bred or appearing in pedigrees are easily identified as being from the Stud.
- It is a way of promoting the Stud and all it has to offer, under one identity.

 For eligibility, please consider the following: A Prefix must be one word only. Initials are not acceptable as a prefix. Dots, dashes and numbers are not acceptable. Singular or plural forms of an existing prefix is not acceptable. Prefixes that sound phonetically similar to an existing registered Prefix are not permitted. The requested prefix must not have been used more than ten times, for previously registered horses.
