DNA Profile - Parentage

Where registered horses are required to be DNA Profiled, the Society requires testing for sire and/or dam verification. From 1st January 2024, all horses will be required to be DNA Profiled and tested for sire and/or dam verification. *Note: Compulsory DNA testing for natural service is being worked through a consultative process and general review. Further details will be released when available. Members are advised, compulsory DNA testing may become a requirement at any time (for any registration type) from 1st January 2024 and requirements will be announced in due course.*

- Horses resulting from NATURAL SERVICE do not require DNA testing for registration purposes (optional).
- All ASH stallions or colts being used for breeding after 1st August 2004 must be SIRE REGISTERED and DNA recorded.
- All foals resulting from ARTIFICIAL INSEMINATION must be DNA Tested and Sire Verified.
- All foals resulting from an EMBRYO TRANSFER must be DNA Tested and Parentage Verified (sire and dam). The DNA information pertaining to the sire and/or dam must be available to the Society.
- All progeny of horses carrying a Genetic Disorder.

- DNA Profile ONLY** **\$95.00** No DNA profile for sire and/or dam, **OR**
- DNA Parentage Verification** **\$95.00** Sire & dam must have a DNA profile.

A DNA kit will be issued to the registered owner with instructions for the owner and a witness (adult) to collect a sample and submit to the testing laboratory. The Society will not release genetic marker information to horse owners.

Genetic Disorder Testing - GDT

ALL SIRE REGISTERED STALLIONS must be DNA tested for Genetic Disorders. Sire Registration is SUSPENDED if stallions are not tested. Genetic Disorder results for POSITIVE HORSES must be disclosed at sales and all breeding opportunities. Results are noted on the horse's registration and provided on the Online Stud Book.

- 6 Panel GDT** (already DNA profiled with ASHS) **\$130.00** (OLWS, HYPP, HERDA, PSSM1, MH, GBED)
In the event, hair previously submitted is insufficient or not available to enable testing for Genetic Disorders, a second sample may be required. Processing of a second sample will incur an additional fee of \$65 to verify it is from the same horse. Should this be required, we will advise you accordingly.
- DNA Record & 6 Panel GDT** (Stallions) **\$225.00** (DNA profile & OLWS, HYPP, HERDA, PSSM1, MH, GBED)
Upon receipt of payment, a DNA kit will be issued to the registered owner with instructions for the owner and a witness (adult) to collect a sample and submit to the testing laboratory. The Sire Registration is suspended until DNA is completed.
- DNA Record & 1 Panel GDT** – HERDA (Mares) **\$140.00** (DNA profile & HERDA)
Upon receipt of payment, a DNA kit will be issued to the registered owner with instructions for the owner and a witness (adult) to collect a sample and submit to the testing laboratory.
