SIRE REGISTRATION

ASH stallions or colts must be Sire Registered for Breeding Purposes, to enable progeny to be eligible for ASH registration as Stud Book, First or Second Cross. ALL SIRE REGISTERED STALLIONS must be DNA tested for Genetic Disorders. Any horses not tested are SUSPENDED. Genetic Disorder results for POSITIVE HORSES must be disclosed at sales and all breeding opportunities. DNA Testing for Sire Registration is 6 panel - OLWS, HYPP, HERDA, PSSM1, MH, GBED.

Upon receipt of payment, a DNA kit will be issued to the registered owner with instructions for the owner and a witness (adult) to collect a sample and submit to the testing laboratory. The Sire Registration is suspended until the DNA process has been completed. The Society will not release genetic marker information to horse owners.
